**CALL TO ORDER:** President Owen Sweeney called the meeting to order at 9:03 a.m. A quorum was present.

**REVIEW & APPROVE AGENDA:** Joel moved to approve the Agenda. Frank seconded. Motion carried unanimously.

PUBLIC HEARING ON FY 2024/2025 BUDGET: No comments from the public were made.

**APPROVAL OF MARCH 28, 2024 MINUTES:** Frank moved to approve the Minutes. Joel seconded. Motion carried unanimously.

TREASURER'S REPORT: Helen Wilson presented the Treasurer's Report.

**FY 2024/2025 JOINT POWERS BUDGET APPROVAL UPDATE:** The FY 2024/2025 Joint Powers Budget has been approved by Dubois, Hudson and Lander. Riverton, Shoshoni and the County Commissioners have yet to approve the budget. Part of the updated form states that "Beginning July 1, 2024, participating communities must use a TAD application that will be provided by the Wind River Visitors Council." Helen Wilson presented that application and a reporting form for use by the distributing entities for their annual report.

Krista asked for clarification about the reporting form, inquiring if a third column for "Amount Distributed" should be included. Helen Wilson said she would add it.

**PUBLIC COMMENTS:** Gary Weisz related to the board how TAD funds were distributed when he was part of the board.

**ADJOURNMENT:** There being no further business to come before the Board, Frank moved to adjourn the meeting. Krista seconded. All were in favor. The meeting adjourned at 9:51 a.m.
